- Water Access fee will increase from \$25.00 to \$27.30 per month,
- Water Usage will increase from \$7.25 per 1000 gallons to \$8.80 per 1000 gallons,
- Sewer Access fee with increase from \$12.50 to \$13.50 per month
- Sewer Usage will increase from \$3.625 per 1000 gallons water used to \$4.50 per 1000 gallons water used.
